




MEMORANDUM OF UNDERSTANDING



1.2. Providing 1 (one) classroom and 1 Lab for training of the said candidates. The classroom to have the facility of a white screen and projector or Smart Panel. The room should have the requisite furniture and the capacity to accommodate at-least 30 candidates at a time.

1.3. Maintenance and cleanliness of the classroom and Lab will be the responsibility of the Govt. Degree College, Solan Classroom utilization, providing separate Wash Rooms for Male & Female students.

1.4. Providing First AID Kit for any untoward incident.

2. Objectives. The Parties agrees as follows:


2.1. The Parties shall work together in a cooperative and coordinated effort so as to fulfill the deliverables of the EEE Project.


2.2. It is not the intent of this MOU to restrict the Parties to this Agreement from their involvement or participation with any other public or private individuals; agencies, or organizations.
